ROSTRAVER TOWNSHIP SEWAGE AUTHORITY MEETING MINUTES REGULAR MEETING DECEMBER 19, 2023

The Regular Meeting of December 19, 2023 of the Rostraver Township Sewage Authority was called to order by Chairman, Dennis C. Manown, at 4.00 p.m., in the Rostraver Township Sewage Authority Administration Building, Rostraver Township, PA 15012.

SECRETARY'S REPORT:

ENGINEER'S REPORT: KLH Engineers, Inc.

The written Engineer's Report was submitted by David Coldren, PE. A copy of the Monthly Report for December 2023 is attached hereto and made part of these minutes.

Mr. Coldren reported the SCADA System plans and specs are about 70% completed. A draft of the plans will be presented to the Board in January. A request will be made to advertise the project at the January meeting.

Mr. Coldren received an updated proposal from Fedora for all of the equipment for the security system. Total cost for equipment is \$140,000. Co-stars price is \$150,000 for the installation from Westmoreland Electric. The recommendation will be to use the grant money to buy the materials via co-stars and put the installation out to bid. Mr. Morgan asked why are we purchasing the equipment from one company and the installation with another. If something goes wrong, they will pass the buck blaming each other. Mr. Coldren said Fedora is an equipment supplier and does not do installations. Mr. Coldren advised if we put both out to bid electrical contractors will be bidding and they are going to Fedora for the equipment. Mr. Gouker agrees with Mr. Morgan, it leaves the option to pass the buck if you do not buy the equipment from the same company who can also do the installation. Mr. Coldren recommends to put it all out to bid as one contract and Fedora will be a subcontractor. Mr. Gilbert said we can put a provision in the contract if they buy the equipment from Fedora, we can buy the equipment ourselves and save the markup. Mr. Coldren agreed.

Mr. Coldren reported a PA Small Water and Sewer Grant was awarded for \$235,000.00 for Sweeney Plan and Clair Manor sewer rehabilitation. The next step is to get the agreement from CFA, get it executed and start the plans and specs. Mr. Morgan asked if this was because of KLH working with Kim Ward's office. Mr. Coldren said this has been going on for a year, so it would be Ann Scott putting it together with Mr. Davanzo's office. Who should we be thanking, Mr. Coldren said Kim Ward. Mr. Coldren reported they applied for two more grants from the LSA Program. Two Hundred Thousand (\$200,000) dollars was awarded for the replacement of the raw sewage pumps at the treatment plant; and \$250,000 for additional sewer rehabilitation.

Mr. Coldren reported that both blowers were received but were supplied with the wrong shaft. The manufacturer and representative are currently looking for a special coupler to connect the blower to the motor. Mr. Gilbert asked if this will integrate with the new SCADA system and are we going to have full control of the new blowers? Mr. Coldren said he does not believe the digester blowers are currently tied to SCADA. He continued saying the next project would be to enhance the plant SCADA. The SBR blowers are tied in. Mr. Gilbert asked if the technology to tie into the SCADA was there? Mr. Colden said yes, we would have to add a PLC.

Mr. Coldren reported that the Finley Road project will begin in January.

Mr. Gilbert asked where we stand on capacity at the plant. Mr. Coldren responded the plant is rated for 1.5 million gallons per day and we are currently as 700,000.
